

- 二、亞洲土木工程大會 (CECAR) 是 ACECC 每三年舉辦一次全亞洲最重要的土木水利工程會議。繼 2019 於東京成功舉辦 CECAR8 後，2022 年將由印度接辦 CECAR9。參與成員遍及亞洲各國含澳洲及美國，預計有超過 700 篇論文發表。目前雖因疫情不穩，實體會議尚在研議中，徵求論文仍依原訂時程辦理。
